...raise £20 for Trinity Hospice

Trinity is the local hospice for the 750,000 people living in our central and south west London catchment area – each year 10,000 people in this community will discover that they have a terminal illness.

Last year, our community nurses cared for 3,500 people in their own homes, and we cared for more than 400 people on our wards. All our services are provided free of charge.

Our priority is to expand our community care services so that more people are able to die in their own home or care home, which is where most people would prefer to be.

People are often surprised to discover that we are a charity and that we receive just 36% of our income from the NHS. This means that we must raise more than £5 million each year to continue providing the specialist care our community relies on.
